At the NUNA Executive Committee meeting on July 2, we heard from Chris Dolman, City Arbors, about a small oak wilt infestation, probably insect-borne, that has cropped up in the SE quadrant at East 32nd and Tom Green. The bad news is that three great old oaks are gone and will have to be removed. The good news is that the infection may be contained just to that area because of the considerable distances to other oak trees. Trenching, which can be prohibitively expensive, will probably not be necessary. Some neighboring trees are at risk, though, and need to be injected. Police Protection Information For Residents

The Austin Police Department (APD) recommends that if there is a problem or an offense "in progress," call 911 and make a complaint. In order to have this complaint followed through, the caller must also request an officer come and speak with him/her. For all other calls or complaints 311 is the number for something which has already occurred and is not an emergency. APD strongly recommends that if you feel that a call to 311 is not satisfactory, by all means, call 911. Assistant City Manager over APD, Chief Michael McDonald, has requested that the word get out about the operator's response to a call; if a caller feels that the operator's response at 911 is inappropriate in any way, he/she should ask to have the operator's supervisor call back immediately. Hang up and wait for the supervisor's call.

A Tribute To Ralph B. Hudson, Jr.

November 14, 1950 - June 17, 2007 By Carol Journeav

Ralph Hudson, a former NUNA resident, had deep Texas roots. He delighted in sharing his family history as well as his extended knowledge of history with friends, family, and neighbors. A descendant of the Hudson family who settled on a bend of the Colorado River in 1854, Ralph was born in Austin and grew up in South Austin. When he wasn't in school (Travis High, UT, and UT Law School), or on the lake, he worked at his parents' café, Hudson Café, also known as The Avenue, on Congress, until he was 33 years old. The Avenue appeared in one of Willie Nelson's movies; Ralph was once an extra in a movie with Peter Fonda! The Avenue later changed hands and is known currently as Las Manitas. Following his time working at the café, Ralph worked for Hogan Demolition.

There was a Hudson settlement on the Colorado that decreased to nearly half its original size when Mansfield Dam was completed in 1940. Remains from the

NUNA Kicks Off Membership Drive

The NUNA Executive Committee will be launching NUNA's membership drive at this year's National Neighborhood Night Out on August 7. The Executive Committee plans to increase membership by 30% this year; it is one of NUNA's top five goals for the year. Douglas Plummer, Secretary of the Executive Committee, has been tasked to head the drive. While a 30% increase seems like quite a stretch, it is obtainable and important. More members not only make us more fiscally sound, but provide us with the volunteer support that we need to get specific tasks completed within the various NUNA projects. Currently, NUNA has a low number of members. Increasing membership by 30% would mean doing the following activities:

- Having a regular sign-up sheet at all neighborhood meetings in order to identify potential members.
- Sending a solicitation letter to all nonmember attendees.
- Asking local neighborhood members to display a "Neighborhood Meeting Next Monday" sign on their lawns to increase attendance at the every-other month meetings.
- Conducting door to door neighborhood walks by volunteers to solicit more members.

Sparky Park Update

It might appear as though nothing is happening at Sparky Park, the site of the former North Austin Substation: this partly is true. But, behind the scenes, the Sparky Park Committee along with other members of the NUNA executive committee have been making "noise" to the Parks Board and the Parks Department with letters and public statements. The substation building was recently broken into; vandalism and graffiti is proliferating on the building. NUNA requests that if anyone- a neighbor or someone walking by, who sees any suspicious activity, to call 911. After the substation break-in, an official sign naming the park, Sparky Park, mysteriously appeared from the Parks Department. This is a small but necessary step forward towards the future development of this park. We do hope that the Parks Department will move more quickly towards the construction of this park than they have in the past. We intend to keep pressure on the Parks Department for the start and the finishing of this small pocket park. Ground breaking for the park design phase is now scheduled for Spring 2008. Hope springs eternal.

Historic House- Here Today, Gone Tomorrow-Call for Local Historic District?

NUNA is in the process of losing another potentially historic house in the Grooms subdivision- a house listed on the 1984 map of contributing historic properties. In fact, the house located at 206 E. Speedway is the oldest extant house in this subdivision, and the second oldest house in the neighborhood. It had various additions that impeded the untrained eye to decipher the original structure. At this very moment, the house is being dismantled piece by piece. To some with historical sensitivities, this is sad; once a structure is removed, a neighborhood loses some of its history.

Here is some background history to this ninetieth century structure. This house was built in 1886 by John McQuiston, a very skilled carpenter (after all, the house was still standing 121 years after construction!). At the behest of Judge Alfred Grooms who owned the land in the present day Grooms subdivision, Mr. McQuiston built a small house on the corner of 30th Street and Speedway. He and his wife, Mary, raised 4 children there. McQuiston worked as a foreman for John A. Greathouse, a prominent builder in Austin particularly in Travis Heights and the West End.

The removal of this old house has ignited a cinder which has kindled a spark- an idea for NUNA to create a local historic district! In the past and during the Neighborhood Planning Process of 2004, a common refrain throughout the neighborhood was to make NUNA as an historic district; as recently as 2006, the City just allowed the formation of local historic districts. In fact, the second goal and second priority in our Neighborhood Plan was to create local historic districts to protect and preserve the historic neighborhoods. NUNA still has a stockpile of historic housing stock, which reflects the 20th century, but only one house remains intact from the nineteenth century (on 34th Street).

Historic status for a property owner has many benefits, including a property tax reduction. Property owners would also be eligible for certain grants for upgrading air-conditioning systems, etc. Historic status usually brings with it elevated property values (esthetic nd monetary) that aid in the resale of a property. With all of the growth in Austin at this moment, it is refreshing to visit an area which has preserved some of the architecture from times gone by.

It would be great to recommence the historic work we tried to get going during the neighborhood planning process, but the onerous workload of the NCCD caused volunteers to become weary.
