# 38th STREET By Ethel Jackson

The City of Austin Urban Transportation Department held a public hearing at the Hancock Recreation Center on June 18th to discuss traffic flow improvements for the 38th/East 38 1/2 Street corridor.

Robert Wunderlich, head of the Transportation Engineering Section, explained
that the purpose of the hearing was to
learn which intersections are most
dangerous or cause the greatest traffic
problems. The hearing did not address
such major projects as the widening of
38th Street.

Mr. Wunderlich introduced Jim Vance, of Barton Aschman Associates, Inc., consultants. Mr. Vance displayed a map of 38th Street from Shoal Creek Blvd. to Airport Blvd. and described his firm's findings at each major intersection. The hearing confirmed those findings in that there is a need for better signalization control, improved left and right turn facilities, and observance of stop signs.

H was pointed out that the continuity of unals is maintained for north-south streets, not east-west (con't p. 4)


